

Fiber Optic Cable Reinforcing Core Grounding Standard



Overview

The current language regarding optical fiber cabling grounding found in the NFPA 70 NEC 2014 is as follows: “ 770. 93 Grounding or Interruption of Non-Current-Carrying Metallic Members of Optical Fiber Cables. This Applications Engineering Note (AE Note) discusses conventional bonding and grounding practices for conductive fiber optic cable and hardware installations within the scope of the National Electrical Code (NEC). Fiber Optic Cable Reinforcing Core Grounding Standard



Installation is similar to installing a messenger wire except it also includes a fiber optic cable that requires careful handling like any other fiber optic cable.



Section 250.53 rules the installation of two or more grounding electrodes described in Section 250.52 to create a grounding electrode system as required by Section 250.50. This section ...



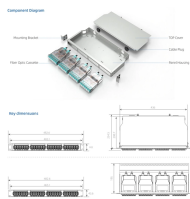
Although most fiber optic cables are not conductive, any metallic hardware used in fiber optic cabling systems (such as wall-mounted termination boxes, racks, and patch panels) must be grounded.



This AE Note addresses only bonding and grounding practices for fiber optic components in the context of the overall bonding and grounding network in commercial buildings.



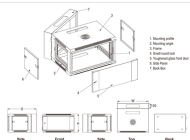
NEC 770.114 - "Non-current-carrying conductive members of optical fiber cables shall be bonded to a grounded equipment rack or enclosure, or grounded in accordance with the grounding ...



The following language is recommended: Fiber optic cables shall be installed in accordance with NECA/FOA 301, Standard for Installing and Testing Fiber Optics. Use of NEIS® is voluntary, and ...



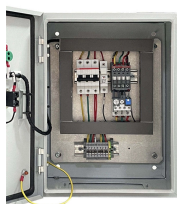
Fiber optic cable sequential numbers are required at each pole location and vault wall. Sequential numbers will identify conduit length, and slack left in vaults and at poles.



This document provides standards and guidelines for aerial installation of fiber optic cables including pole setting, grounding, cable runs between poles, and fiber optic cable handling.



This standard covers fiber optic cabling installed indoors (premises installations) with the addition of outside plant (OSP) applications involved in campus installations where the fiber optic cabling ...
