Lati Paraguay operates approximately 300 wireless communications towers in Paraguay. This strategic acquisition, signed on April 26, 2025, aims to enhance ATIS's position as the premier independent tower company in the Southern Cone. ATIS Group, a digital infrastructure provider in Latin America, announced late last week that it had entered into a definitive agreement with Millicom, a provider of fixed and mobile telecommunications services in Latin America, to acquire Lati Paraguay, a subsidiary owning approximately 300. BUENOS AIRES, Argentina -- (BUSINESS WIRE)-- ATIS Group ("ATIS"), a leading digital infrastructure provider in Latin America, today announced that it has entered into a definitive agreement, signed on April 26, 2025, with Millicom (NASDAQ: TIGO) to acquire Lati Paraguay, a subsidiary owning. The towerco will lease the approximately 280 tower sites to Tigo Paraguay on a new 15-year lease. The final number of towers covered under the leaseback will be determined at the time of closing, which is expected to take place in the near term.

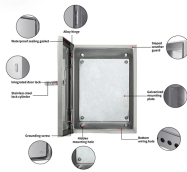
