Per the Washington Employment Security Division, WALTC is the code that will be used for WA Cares deductions. WAPML is Washington Paid Medical Leave. 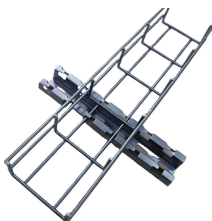

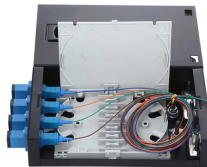
